
































#### **WASD** collaborate with UN on Policy Research

WASD has been selected by the United Nations Joint Inspection Unit (JIU) to work closely with JIU in the policy uptake project A.435. The JIU published a report entitled "Strengthening the policy research uptake in service of the 2030 Agenda for sustainable development" on Wednesday 20 March 2019.

The aim of the report serves to strengthen the role of the UN as the provider of reliable research.

According to the report, achieving the UN Sustainable Development Goals (SDGs) requires evidence-based policies and planning at every level.

For the first time in 52 years, the UN consulted academics and researchers on policy research uptake in the UN. This was because JIU had not been able to find any comprehensive assessments of research policies and activities in the UN system.

with JIU in 2018 on the Role of Public Private Partnerships (PPPs) in the Implementation of Agenda 2030, leading to an invitation, alongside four other global academic networks, to work closely with the JIU in the policy uptake project.

JIU was keen to complement its findings from the participating organisations by incorporating academic perspectives. By engaging WASD, amongst others, JIU was able to identify ways for the UN to make the best use of external knowledge resources and build bridges with the academic community. The partnership between JIU and WASD has proven successful; in 2016, WASD president, Allam

Ahmed, participated in the JIU Conference on knowledge management held in Geneva, and JIU was represented at the WASD Conference held in Manama 2017. For the first time, a paper was co-authored by a JIU inspector and an academic; this paper was published in the World Sustainable Development Outlook 2018.

2019 is looking to be another successful year for the partnership; JIU is planning to undertake a UN system-wide review of policies, programmes and platforms to support learning. JIU will conduct a review in which e-learning platforms will be used to enhance the adequacy of training policies, once again in collaboration with WASD.

20. <sup>11</sup> To complement the standard practices of the JIU, the review team used ad hoc tools to capture, in a more comprehensive way, the intellectual contributions of professional researchers. To that end, the team designed and disseminated a survey to non-United Nations research and academic institutions and think tanks, hereinafter referred to as the "academic survey". The eademic survey contained 10 multiple-choice perception questions and a mini-questionnaire consisting of 3 open-ended questions on substantive issues. The World Association for Sustainable Development (WASD), the Academic Council on the United Nations (ACUNS), the International Studies Association, the Chairs Network of the United Nations Educational, Scientific and Cultural Organization (UNESCO) and the Centre national de la recherche scientifique (CNRS) disseminated the questionnaire through their respective networks. The survey was taken by 492 respondents, 229 of whom responded to the open-ended questions, an analysis of the results is presented in chapter VIII. <sup>17</sup>
